Details about each list:

Thematic tags: ESG

Our goal is to create a taxonomy that is of manageable size and has clear terminology, so that different authors are likely to pick the same term for similar content, and that the terms make sense for those searching for content. We also want to ensure that it contains the terms that publishers are writing research content about and that research consumers are searching for. In other words, when a publisher or a consumer uses a dropdown list with this taxonomy, it should not be too long, vague, or confusing, and it should contain the terms that they expect to be there.

Summary: Rather than starting with a blank slate and asking members to provide recommended terms, we have developed a list to serve as a starting point. This is not necessarily the list we are recommending, but rather is one we would like people to analyze. How? <ul style="list-style-type: none">For publishers, we would like you to consider the ESG-related research that your firm publishes and the ESG-related topics that your firm includes in any of your company reports, sector overviews, models, etc.For vendors, we would like you to consider your current and upcoming products’ needs.For consumers (including buy-side firms, but also sell-side firms and vendors who have a sense of their clients’ needs and preferences), we would like you to consider how individual end users would like to find ESG-related content – what terminology does your firm use, how granular do they need to be, etc.	Enumeration values: ESG Environmental Air and emissions Energy Land and land use Mining, metals, and minerals Waste (including hazardous waste) Water & wastewater Social Data privacy and security Diversity, equity, and inclusion Health and safety Human rights Governance Labor practices Management Regulatory Risk management	
Notes: <ul style="list-style-type: none">The objectives of this list are to bring like content together and to facilitate searching. Thus, we want to strike a balance that adds a bit more depth than simply ESG, Environment, Social, and Governance; yet that doesn’t have so many options that it becomes inconsistently used or overwhelming.		
Questions: Taking the above in mind, when you look at the initial ESG list: <ul style="list-style-type: none">What terms are missing from this list?What terms would your firm never use?Do you have any recommended alternative wording?Can you easily map from this list to the proprietary list your firm uses (and vice versa)?Does this level of granularity make sense for your firm’s needs?What ESG-related topics does your firm publish on and/or do your investment professionals want to search for? This includes ESG topic-based research AND the ESG-related issues covered in company/industry research in sufficient depth that the publisher would want to highlight it.
