Highlights

from our Last Quarterly Meeting

The RIXML organization held its third quarterly members' meeting of 2018 at the 277 Park Avenue office of Raymond James in New York City. Jay Clarke was the host. Jim Ulrich, RIXML Executive Director, opened the meeting with his welcoming remarks.

Carmine Sorice from Qlarity joined us as our guest speaker. His theme was Digital Transformation. Carmine led us in a discussion of key questions: How do we automate our business processes? How do we get any business insight from all the information we are collecting? How do we manage the risk of growing volumes and complexity of content? How do we use information to better engage customers, partners, and employees?



The presentation covered cloud strategies, comparing on-premises, public cloud, private cloud, and hybrid cloud ideas. Cloud platforms attract businesses with agility and mobility as witnessed in the spaces around Dev Ops, Machine Learning, and Internet of Things.

Roman Kitov followed with his Treasurer's Report for the preceding quarter. Sal Restivo gave an update on the activities of the Standards Committee. Deirdre Goldenbogen joined Jim to review the Interactions and Link-Back work streams.

The Interactions work stream has gotten the most time and attention this past quarter. The organization is moving forward to an upcoming v1.1 release of the RIXML Interactions Schema. The group has been reviewing about 40 proposed amendments and associated questions in a series of conference calls during the past few weeks. Those proposed amendments have been discussed and categorized and will ultimately become the basis for the next production release.
